NOTICE INVITING QUOTATION FOR FRUITS

Sealed quotations are invited for Fruits as per Annexure for Dining Hall at Tuljapur Campus Tuljapur - 413601. The intending bidders shall submit their quotes in a **sealed cover with name of the firm & title of quotation (ie. Quotation for Fruits)** super scribed on the envelope addressing to “The Deputy Director, Tata Institute Of Social Sciences, Tuljapur Campus, Apsinga Road, Tuljapur - 413601”.

*** THE QUOTATION PERIOD IS FROM 1st June 2017 TO 30 November 2017.**

Quotation Submission Period is from 13th May 2017 to 22nd May 2017.

We shall expect the following conditions:

- 1. It is expected to provide fresh quality fruits at all the times.**
- 2. Rate should be as per Kg as specified in the annexure for each item. As many of the fruits mentioned in Annexure are seasonal, the standard monthly average consumption will vary.**
- 3. Quoted rates shall be inclusive of all taxes (Sale tax, VAT or any other tax on materials) and transportation charges. The Institute will not entertain any claim whatsoever in this regard.**
- 4. Each fruit must be intact even during transportation, food handling and storage.**
- 5. In case of unavailability of any fruit as mentioned in weekly menu, a substitute can be supplied only after approval from Authorized person at Dining Hall.**
- 6. Quality and quantity of the material will be checked and approved by the designated authorities of the Institute.**
- 7. Fruits should always be supplied along with an appropriate Challan/ Invoice.**
- 8. The Institute reserves right to reject the inferior quality of supplies and will not pay for the same. The Institute’s decision in this regard will be final.**
- 9. Contractor shall obtain necessary gate pass from the Security Officer at Tuljapur Campus**
- 11. Fixed Period of contract will be 06 months.**

- 12. Fruits need to be supplied at above mentioned address within the stipulated period as mentioned by respective DH Authority. The DH supervisor will place order with the supplier at least 24 hours before the serving of fruits.**
- 13. Bills for 15 days should be submitted for which the payment will be made in 15 working days through cheque.**
