**We shall expect the following conditions:**

- 1. Rate quotes for each vegetable should be as per annexure. Please provide fresh quality products where no specification mentioned.**
- 2. Rate should be as per Kg as specified in the annexure for each item. **Please do not give the rates for bundles or numbers.****
- 3. Quoted rates shall be inclusive of all taxes (Sale tax, VAT or any other tax on materials) and transportation charges. The Institute will not entertain any claim whatsoever with regards to this.**
- 4. Each item must be intact even during transportation, food handling and storage.**
- 5. In case of unavailability of any vegetable in terms of specification (quality &/or quantity), substitute vegetables can be supplied only after approval from Authorized person at Dining Hall.**
- 6. Quality and quantity of the vegetables will be checked and approved by the designated authorities of institute.**
- 7. Every supply of vegetables should be accompanied by an appropriate Challan.**
- 8. The vegetables should be delivered at respective dining hall and arranged by the principle of “First in, First out” in the designated storage area by the delivery person.**
- 9. The Institute reserves right to reject inferior quality of supply and will deduct money or will not pay for the same. The Institute’s decision in this regard will be final**
- 10. Contractor shall obtain necessary gate pass from the Security Officer at the Main Gate of Institute.**

**11. Fixed Period of contract will be 06 Month.**

**12. Bills for 15 days should be submitted for which the payment will be made in 30 working days through cheque.**
