TISS is a centrally funded Deemed to be University under University Grants Commission (UGC), Ministry of Education (MoE), Govt of India (GoI), and operates from its main Campus in Mumbai and Off-Campuses at Tuljapur, Guwahati and Hyderabad. The Institute is ranked among the top 40 Indian Universities (37th rank- NIRF 2021) and its Social Work study program bagged the First rank in India Today College Survey for fourth year in a row.

Prayas is a field action project of the Centre for Criminology and Justice, School of Social Work. Initiated in 1990, it is a response to the needs of disadvantaged groups being processed by the criminal justice system. It aims at socio-legal and economic rehabilitation of persons who are at risk of being criminalized, exploited for commercial sex, and those in destitute states.

Prayas invites interested candidates to apply for the post of **Senior Accounts Manager** (on contract for two years).

Consolidated salary: Approximately Rs. 45000 to Rs. 50000 per month (including TA for field work), subject to experience.

Preferable age: Age Limit upto 50 years as on 31 December, 2021.

Nature of appointment: Contract basis from March 1, 2022 to March 31, 2024 (2 Years).

Location: MUMBAI, NAVI MUMBAI, THANE

The last date for receipt of online application: 28 February, 2022.

This is a full-time position. Candidates residing within **municipal limits of MMR (Mumbai Metropolitan Region)** or those able to travel to Mumbai for daily work are invited to apply. When required, the selected candidate will also be required to travel to other districts.

Qualification and Experience:

Masters in Commerce with at least 55 per cent or an equivalent grade in a point scale. The candidate must have completed a course of MSCIT and TALLY from a government recognized institution and have minimum six years of work experience in the field of Finance and Accounts. Preference will be given to those candidates who have:

- Completed ICWA/CA/MBA (Finance) or CA/ICWA (Intermediate) with five years of work experience.
- Good knowledge of finalization of accounts of charitable organizations, charitable trusts statutory requirements, and expertise in direct and indirect taxes.
- Good knowledge of maintenance of books of accounts as per foreign accounting norms, and knowledge of Home Ministry returns.
- Excellent knowledge of budgeting and multiple accounting & finance management.
- Ability to work effectively in teams as well as independently.
- Experience in working on ERP software.
- Proficiency in Word, Excel, Tally and Power Point.

Shortlisted candidates will be invited for the interview.

Application Fee: Application Fee for Rs 500/- to be paid online for candidates from General, OBC & EWS categories. Application fee for SC/ST/PWD candidates will be Rs 125/-, if they attach the required Certificate with the online application form. **The women applicants are exempted from the payment of application fees.** The application will be valid only on receipt of the application fee, if applicable. Fees once paid shall not be refunded under any circumstances.
